EXECUTIVE SUMMARY

A detailed examination of the expenditure, employment, and tax impacts generated by the Kentucky tourism and travel industry, as well as the industry structure, has been conducted for the Kentucky Tourism, Arts & Heritage Cabinet. The major findings of the 2012 study follow:

- The tourism and travel industry contributed over \$12.2 billion to Kentucky's economy in 2012. Direct expenditures by tourists accounted for nearly \$7.8 billion of this total – an increase of 4.4 percent since 2011.
- The 2012 tourism industry generated over \$1.227 billion in tax revenues to government - \$1.113 billion to the state and \$164.4 million locally. This is an increase from \$1.223 billion in tax revenues in 2011.
- All nine tourism regions showed gains in revenues between 2011 and 2012. The largest increase occurred in the Bourbon, Horses, & History Region. It increased by 6.3 percent between the two years.
- A total of 174,006 jobs in Kentucky resulted from the industry in 2012—up 4,078 jobs from 2011. Direct expenditures created 121,768 of these jobs.
- The tourism-generated jobs provided over \$2.7 billion in wages to Kentucky workers – an increase of nearly \$117 million from 2011 wages.

¹The indirect and induced expenditures resulting from the initial infusion of money into the Kentucky economy were calculated using the RIMS II input-output (I-O) model developed by the U.S. Department of Commerce, Bureau of Economic Analysis. The output from the Certec Model© served as data input for the I-O model. The latter model provided indirect expenditures resulting from the tourism industry.
