OUR VISION

Lexington-Fayette County will be the model for sustainable growth by balancing and connecting our vibrant city with our productive and beautiful Bluegrass farmland.

OUR MISSION

The Fayette Alliance is a coalition of citizens dedicated to achieving sustainable growth in Lexington-Fayette County through land use advocacy, education, and research.

As the voice for sustainable growth, Fayette Alliance believes that preserving our unique and productive Bluegrass farmland, advancing innovative development, and improving our infrastructure are essential to our collective success in Lexington.

Through our efforts at government and beyond, Fayette Alliance positively impacts countywide planning and zoning policies—which are the building blocks of a better quality of life, economy, and environment for us all.

To date,

Favette Alliance has worked with City Hall to usher MORE THAN 128 MAJOR LAND-USE POLICIES into the books-from supporting **OVER \$750 MILLION IN INFILL PROJECTS,** establishing needed water quality improvement under the EPA Consent Decree. programs SAVING 8,000 ACRES OVER FARMLAND from sprawl development, and successfully advocating for NO EXPANSION OF THE URBAN SERVICES BOUNDARY in the 2018 Comprehensive Plan.

AT THE MERCHANISH THE CHARGE CONTRACT AND THE COST OF

ADVOCACY

- Supported adoption of the completed 2018 Comprehensive Plan, Imagine Lexington, representing a continued commitment by the City Council to smart growth policy as advocated by Fayette Alliance. On February 28, 2019, an update process spanning 2017 and 2018 was brought to fruition, with Fayette Alliance playing a central role throughout, serving as an expert on specific thematic areas and providing research and other resources. Phase one, in 2017, identified the goals and objectives of the plan and achieved the critical goal of no expansion of the Urban Services Boundary. Phase two, in 2018, set out implementation items necessary to accomplish the goals and objectives, and the recommendations throughout largely align with our vision. These recommendations are currently being implemented and Fayette Alliance will continue to monitor and advocate for sustainable, responsible growth policies to be put in place which are consistent with the community vision set out in the Plan.
- Supported continuing education on Placebuilder, a zone change framework within the 2018 Comprehensive Plan. A new tool intended to provide greater transparency, clarity and detail, Placebuilder operates as a framework by which developers, neighbors and community stakeholders may evaluate whether a zone change is in agreement with the Plan. Fayette Alliance supported Planning Staff's continuing education efforts on this tool throughout the city to neighborhood associations, developers, key stakeholders as well as a presentation and educational discussion with our Board of Directors. Fayette Alliance supports the intent of Placebuilder and its goal to encourage creativity in how our community accommodates growth and we will continue to evaluate its effectiveness as zone changes move through its process.
- Supported funding for PDR program in FY20 budget. Due to a restricted budget year but in order to show support for a critical program, the PDR program was funded in the amount of \$401,000 in the FY20 budget in order to cover current applications and expenses. Fayette Alliance expressed public support for full funding of the program and concerns regarding precedent setting budget allocations moving forward, but also understand the revenue shortfalls the new administration faced in FY20. We will continue to monitor budget discussions around PDR and support full funding in FY21 and beyond.
- Supported funding for the Affordable Housing Trust Fund in LFUCG FY20 budget. Full funding for the program in the amount of \$2 million was provided.
- Served on the LFUCG Infill & Re-development subcommittee to examine and identify ways in which our city can better encourage responsible infill projects as we continue to grow. Fayette Alliance will continue to serve on important this subcommittee as we move forward implementing the goals and objectives of our Comprehensive Plan.

- Opposed Amendment 1 to House Bill 346 in the Senate which, if passed, would have transferred control over local land use decisions to representatives in Frankfort. Senator Jared Carpenter introduced a bill late in the 2019 legislative session which would have given control over land use decisions, Urban Service Boundary expansions, infrastructure investments and budget priorities to the state pursuant to an economic development mandate. Fayette Alliance joined partners Mayor Linda Gorton and LFUCG, Kentucky Thoroughbred Association, Kentucky Farm Bureau, Kentucky League of Cities, and Kentucky Association of Counties, in opposing this bill and it's removal of local control and the amendment was quickly withdrawn. Fayette Alliance will continue to closely monitor the 2020 legislative session and beyond for the introduction of bills with similar implications.
- Monitored review of the Purchase of Development Rights Ordinance and program conducted by the Rural Land Management Board and board created committees. Fayette Alliance has always championed the PDR program, a national model, and shall continue to be actively engaged in and supportive of the process of making updates and changes to the ordinance that keep the original goals and purposes of the program in mind.
- Supported expedited zone change approval process for uncontested Planning Commission decisions. Balancing efficiency in the routine zone change process and protection for neighborhoods and citizens from complications and unintended consequences is critical in achieving our objectives for infill and re-development as set out in the Comprehensive Plan. Fayette Alliance, while supporting the ZOTA, provided specific recommendations to ensure citizen protection should it move forward. An effort to identify meaningful ways for neighborhoods and developers to engage early in the process, leading to greater communication and consensus in the development process, is being studied by community stakeholders and is ongoing. Fayette Alliance will continue to monitor these efforts and their community-wide implications.

- Monitored a conditional use permit application for a bistro and event space on a small farm winery in the A-R zone. The primary intent of the A-R zone is to encourage production agriculture and protect the rural character of the Bluegrass. Conditional uses in the zone may be permitted if they are "subordinate and incidental to" the small farm winery, which is permitted by right, but the statute fails to specify how related these conditional uses must be to the land itself in order to be consistent with the original intent of the zone. While Fayette Alliance supports agribusiness and agritourism, it is critical to protect our irreplaceable agricultural assets from unintended consequences and ensure the uses of our land remain consistent with the intentions of the A-R zone. Fayette Alliance encouraged careful consideration of unintended consequences of permitting such conditional uses. While disapproved in this particular situation, we will continue to monitor similar issues moving forward.
- Monitored a text amendment to incorporate and regulate Accessory Dwelling Units (ADUs). While we supported the intent of the proposed amendments to provide an alternate housing choice to incrementally increase density and efficiently utilize existing infrastructure, we had concerns about unintended consequences to neighborhoods and recommended limiting occupancy in the ADUs and requiring owner occupancy in one of the structures. In response to extensive community, stakeholder and Planning Commission concerns, Planning Staff modified the ordinance to accommodate these recommendations and include more comprehensive neighborhood protections. Planning Commission approved the ZOTA and we will continue to monitor it as it is considered by Council.
- Monitored development plans and strategy by the Urban County Industrial Authority for 250 acres of economic development land acquired by City in historic land swap. Fayette Alliance presented to the Authority on smart growth and encouraged establishment of a Master Plan to maximize economic development opportunities, utilization of land for a modern workforce, and recommended a surrounding corridor study to further evaluate and enhance development and transit potential. Plans are ongoing and we will continue to monitor.

- Supported ordinance updates to expand sidewalk widths and require appropriate bicycle facilities and shared use paths in new developments. Diversifying transit options, prioritizing pedestrians and encouraging transit efficiency help promote walkability, economic development, and enhance our quality of life.
- Presented at the Bluegrass Tomorrow Rural Land Use Partnership Summit on smart growth, the economic impact of agriculture on our local economies and the importance of continuing the conversation of regional land use planning as our communities grow. Fayette Alliance serves on the Rural Land Use Partnership subcommittee which engages in important conversations about furthering regional communication surrounding land use.
- Served on Engagement Committee for On The Table 2020, which will focus on neighborhood change. On The Table is a community-wide conversation which engages thousands of Lexington-Fayette County citizens in important discussions about their community. We will continue to be engaged in this process and look forward to On the Table, set for March 25, 2020.
- Monitored work of the Sustainable Growth Task Force, a group appointed by Mayor Linda Gorton pursuant to the mandate of the 2018 Comprehensive Plan. It held its first meeting in December 2019 to discuss its charge of hiring a consultant and developing objective criteria to evaluate Lexington's continued growth. We will continue to monitor the work of the Task Force and its incredibly important implications for Lexington's future land use policy decisions.

- Served on the ULI KY Lexington Programming and Outreach Committee, the On The Table 2020 Engagement Committee, the Locust Trace Principal's Advisory Committee, and the Infill and Redevelopment Steering Committee.

IT'S NOT IF WE GROW, IT'S HOW

Lexington must diversify its housing stock to meet pressing housing needs for accessible, low-maintenance housing such as condos, townhouses, duplexes, fourplexes, and single-family detached homes on small lots.1

According to a 2017 study, Lexington's land use policies do not appear to be currently causing housing prices to grow faster than prices for the state, nation, and comparison cities... Lexington is experiencing considerably less upward pressure on (housing) prices than the nation as a whole. 4

IMAGINE LEXINGTON, 2018 COMPREHENSIVE PLAN UPDATE

Fayette Alliance was an integral part of the 2018 Comprehensive Plan update, a process which spanned two years (2017 and 2018) and was ultimately adopted by the Lexington-Fayette Urban County Council in February 2019. Since then, Planning Staff has been carefully working on implementation of the goals and objectives set forth in the Plan through policy and ordinance changes, which Fayette Alliance has been closely monitoring.

For the vision of smart growth to become a reality, our community must unite to support policy changes that allow us to achieve our goals to enhance our city and protect what makes Lexington a great place to live, work and play.

Text amendments introduced by Planning Staff include changes to allow for an expedited zoning process in uncontested zone change, accessory dwelling units (ADUs), updates to expand sidewalks and bike lanes, and to require signage around stub streets indicating existence of future development. Fayette Alliance has been communicating with Planning and other stakeholders regarding these changes, as community engagement continues to be critical to the success of Plan implementation.

In addition, zone changes have been making their way through Planning Commission under Placebuilder, a framework within the Plan to evaluate whether proposals for development are consistent with the Plan. In response to community feedback on the lack of effective communication between developers and neighborhoods, Planning Staff has convened a group of stakeholders to work on a Public Engagement Tool-kit, which can be utilized by both parties to encourage meaningful engagement between the two.


The Sustainable Growth Task Force mandated by the Plan held its first meeting in 2019 to discuss its charge to hire a consultant to develop objective criteria by which to evaluate and direct Lexington's future growth and land use policy. Fayette Alliance will be closely monitoring the progress and work product of the group which will have important implications for our work and our city's future. We will engage in both advocacy and research efforts around this effort, so stay tuned!

We look forward to continuing to work with the Planning Staff and the community in implementing the Plan to achieve the goals and objectives identified in the Plan.
